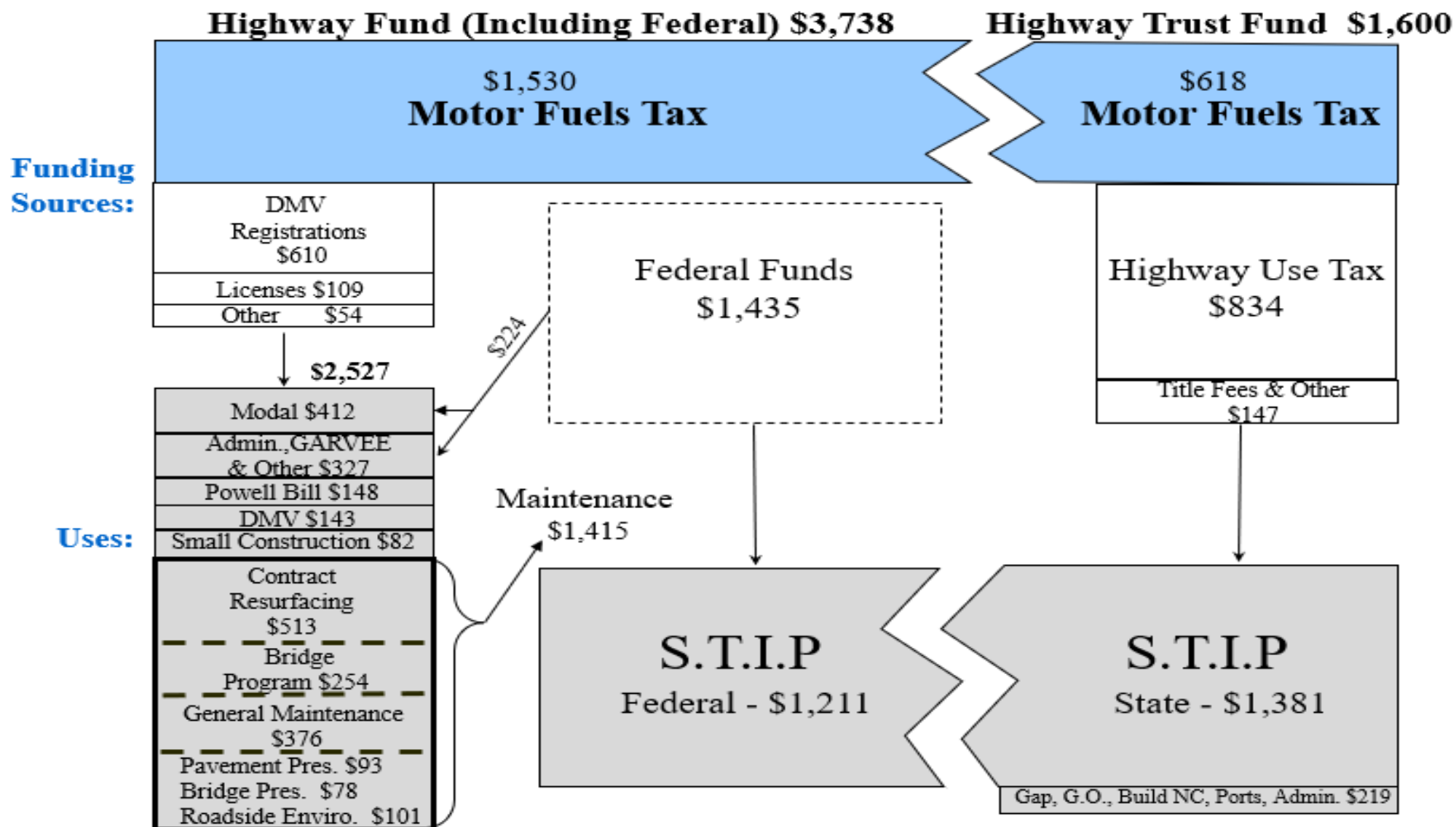

# Highway Fund and Highway Trust Fund Budget, SFY 2019-20

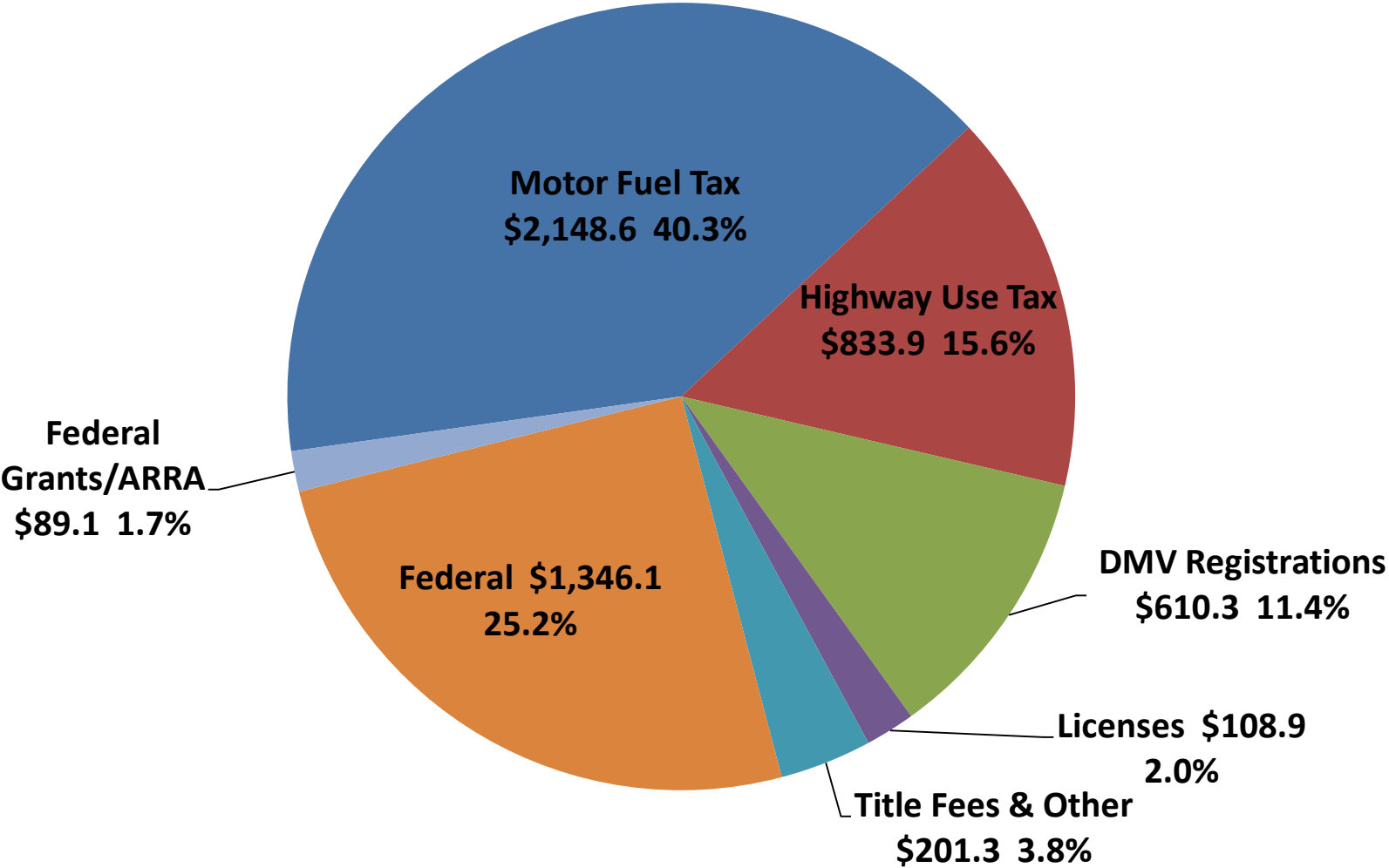

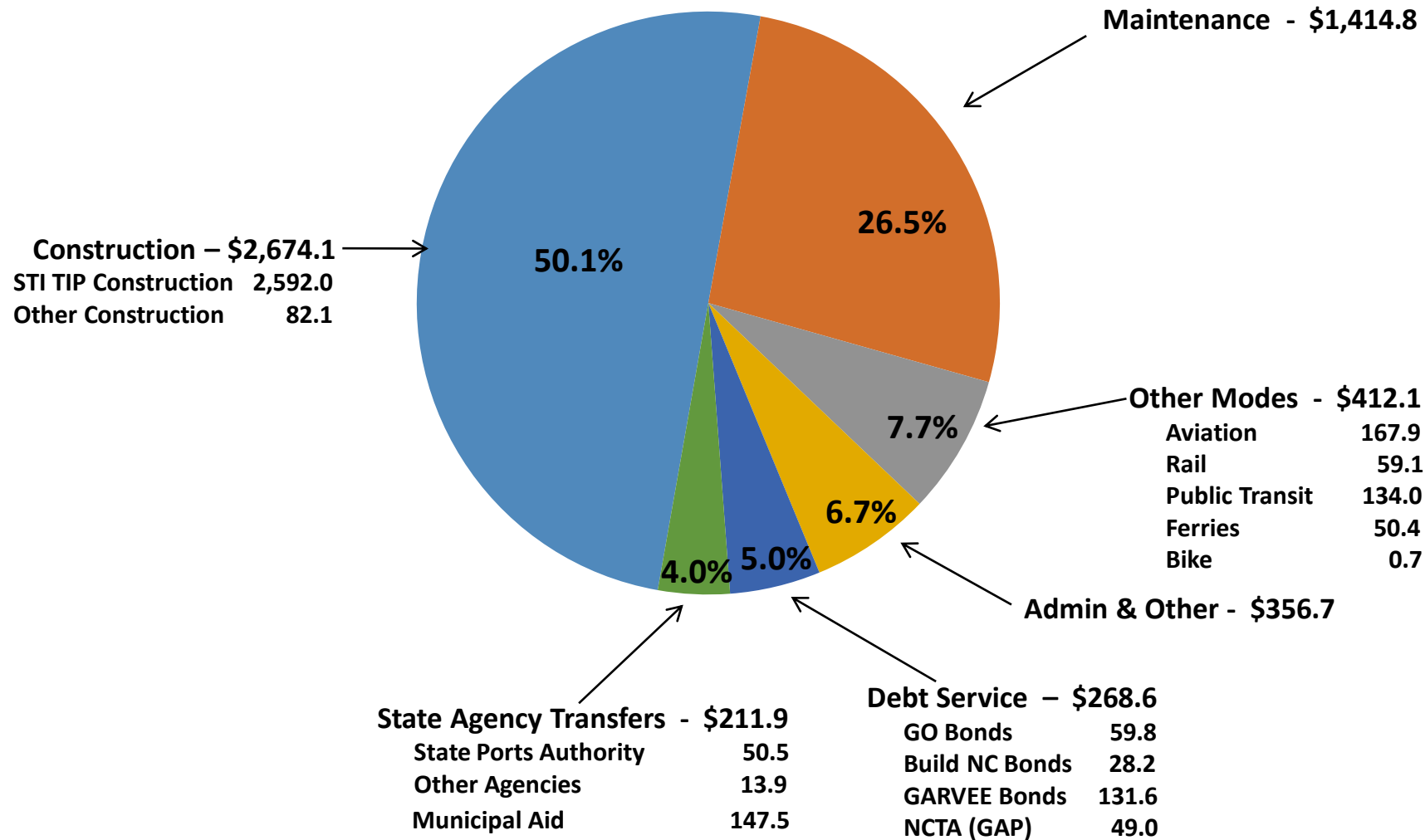

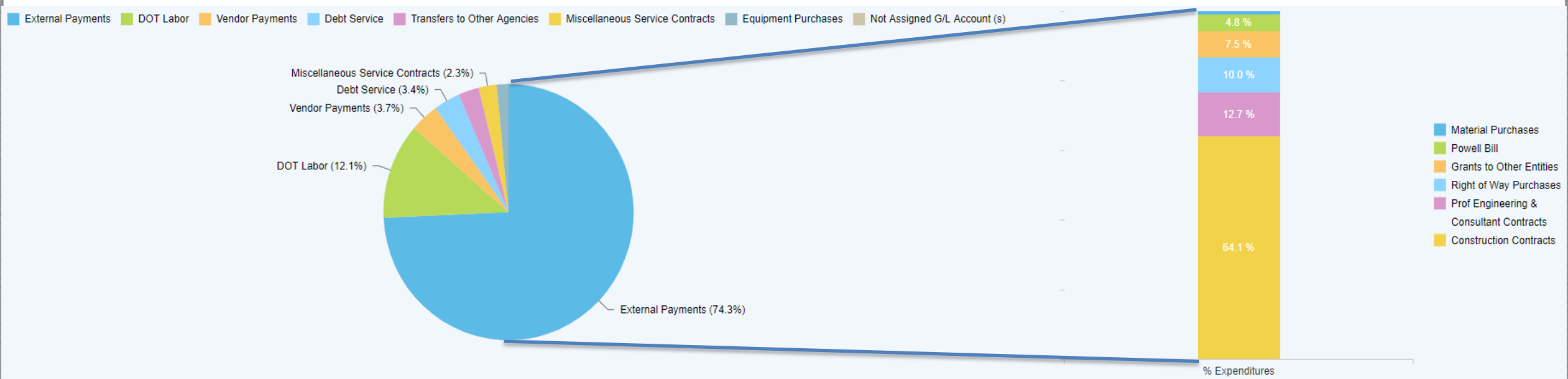
