Opening Comments –

J. J. Eden, NCTA Executive Director

Discussion Summary

Mr. J.J. Eden began the opening comments with an update on the Triangle Expressway, stating revenue for August increased 18% year-over-year with nearly \$5.1 million.

The month of August remained strong with over 5.1 million transactions. The NC Quick Pass Transponder AVI rate made up 59% of those transactions.

Mr. Eden gave an update on the Monroe Expressway, stating transactions for the month of August were nearly 3.7 million, with a penetration rate of 35.4%. Mr. Eden stated revenue for Monroe was nearly \$1.9 million.

Mr. Eden stated the month of September had over 24,000 transponders distributed with nearly 698,000 distributed program-to-date as of September 30.

Mr. Eden shared the news of Turnpike's Director of Communication Carly Olexik's resignation and the interim point of contact for Communications will be Logen Hodges.
