# Call to Order & Approval of March 19, 2020 Meeting Minutes – Montell Irvin, PE, Chair

#### **Discussion Summary**

Chairman Irvin called the meeting to order and stated the Operations Committee minutes for the March 19, 2020 meeting were distributed prior to the meeting.

# Opening Comments – J. J. Eden, NCTA Executive Director

#### **Discussion Summary**

Mr. J.J. Eden began the opening comments with thanking everyone for all the sacrifices made to keep life going during this uncertain time of the COVID-19 crisis.

Mr. Eden gave an update on the Triangle Expressway, stating revenue for February increased 17.7% year-over-year with over \$5.1 million.

The month of February remained strong with over 4.5 million transactions. The NC Quick Pass Transponder AVI rate increased 5.3% year-over-year.

Mr. Eden gave an update on the Monroe Expressway, stating transactions for the month of February were nearly 2.7 million, and revenue was \$1.8 million.

Mr. Eden stated the month of February had over 18,500 transponders distributed with nearly 808,000 distributed program-to-date as of February 29, 2020.

Mr. Eden invited Mr. David Roy to share Turnpike's finance details since the Coronavirus. Chairman Irvin inquired if Turnpike would be impacted by the CARES ACT stimulus relief for tolling facilities. Mr. Eden explained Congress included transit in the stimulus relief and not surface transportation for highway.

Chairman Irvin inquired if Turnpike approval and signing of contract documents would be impacted if NCDOT goes below the cash floor. Mr. Eden stated legal is currently working with legislation to interpret the law.
