# Welcome, Introductions, Call to Order & Declaration of Quorum – Robert Teer, Chair

#### **Discussion Summary**

# Approval of January 20, 2021 Meeting Minutes – Robert Teer, Chair

#### **Discussion Summary**

Chairman Teer noted everyone received a copy of the meeting minutes prior to the meeting and announced he would accept a motion to approve the January 20, 2021 meeting minutes as written.

# Opening Comments – J. J. Eden, Executive Director

#### **Discussion Summary**

Mr. J.J. Eden started his opening comments by providing updates on the Triangle Expressway; stating that there were over 3.57 million transactions in February. Mr. Eden stated that February revenue for the Triangle Expressway was around \$3.01 million. Mr. Eden also provided updates on the Monroe Expressway and stated that the facility had over 2.58 million transactions in February with revenue around \$1.78 million.

In February, the NC Quick Pass program sold around 12,200 transponders which brings the total number of transponders sold to over 952,500 program-to-date. The team is eagerly anticipating the millionth transponder sale and will be hosting events celebrating such.

## Complete 540 Construction Update – Dennis Jernigan, PE, Deputy Chief Engineer for Highway Operations

#### **Discussion Summary**

Mr. Dennis Jernigan provided a Complete 540 Construction update to the Board of Directors.

Mr. Jim Walker inquired Mr. Jernigan to give more explanation to "turbine interchanges". Mr Jernigan explained that a "turbine interchange" is a type of style of interchange; similar to a roundabout, except with three major facilities. It was requested that Mr. Jernigan share the interchange and turbine visualization with the Board. He stated he would do so.

Mr. Robert Teer inquired about the engineering behind project of this. Mr Jernigan explained that for this project, the design traffic was for the 2040 year. Mr. Teer stated that it was important to state that roads are being built not for the present, for the future. Mr. Jernigan agreed.

Mr. David Roy explained that while NCTA receives a portion based on an agreement to cover cost of operating a customer service center, the remainder goes to I-77 Mobility Partners. Mr. James Eden added that the I-77 Project is not a Turnpike project. Turnpike is acting as a contractor performing for NCDOT. Mr. Rodger Rochelle added that I-77 MP posts quarterly gross revenue reports on their website; the Calendar Year 2020 report states about \$4.8 million.
