### Feds Change Numbering System for Government Contracts & Federal Grants

The federal government recently streamlined the process that grant recipients use to identify and validate their organizations or entities. Effective April 4, anyone who receives a federal grant, including from the Federal Highway Administration, will no longer use



the Dun & Bradsheet's Data Universal Numbering System, or DUNS Number. Instead, agencies receiving the federal grants must now use their Unique Entity ID as their authoritative identifier. This will include any sub-recipients that received federal grants through NCDOT.

#### **Bipartisan Infrastructure Bill Update**



The department anticipates receiving \$410 million in new funding each year over the next five years as part of the passage of the Infrastructure Investment & Jobs Act of 2021. This welcomed infusion of federal money has helped us close a projected programming gap in the Statewide

Transportation Improvement Program to \$8 billion over 10 years.

The N.C. Board of Transportation will receive a preliminary draft of the <u>STIP (2024-2033)</u> this spring..
