4 This section establishes the rules for vehicle registration in North ~~including Carolina. The areas covered are:~~

- 5 (1) manufacturer's certificate of origin;
- 6 (2) registration of out-of-state vehicles;
- 7 (3) custom built vehicles;
- 8 (4) motor homes;
- 9 (5) purchase information required for registration;
- 10 (6) buses for hire;
- 11 (7) date vehicle first operated in North Carolina;
- 12 (8) application for title only;
- 13 (9) power of attorney;
- 14 (10) acknowledgements;
- 15 (11) certified record fees;
- 16 (12) registration of leased vehicle;
- 17 (13) duplicate titles;
- 18 (14) salvaged vehicles; and
- 19 (15) penalty for failure to transfer registration.
